I HEREBY revoke All Wills and testamentary instruments heretofore made by me.

I APPOINT Stanley Edward Naish of Old Bond Street Chambers Bath aforesaid and Harry Lincoln Milsom of The End House Malcolm Road Wimbledon London SW19 to be the Executors and Trustees (hereinafter called "my trustees") of this my Will.

I DIRECT that my Trustees shall so soon as conveniently may be after my death pay all my just debts and my funeral and testamentary expenses.

I GIVE DEVISE AND BEQUEATH the whole of my Estate both real and personal of whatsoever nature and wheresoever situate to my Trustees UPON TRUST that they shall sell call in and convert the same or such part thereof as does not consist of money and stand possessed of the proceeds therefore UPON TRUST to invest the same in Trustee securities and to pay the Income therefrom to my Wife Gertrude Edith Milsom for her life and at her death I DIRECT my trustees shall stand possessed of my said Estate UPON TRUST for my Son Anthony Robert Clifford Milsom for his own absolute use and benefit.

PROVIDED that any Trustee for the time being of this my Will being a Solicitor shall be entitled to charge and be paid free of all duty or other charges all professional charges for any business or act done by him or his firm in connection with the proving of this my Will or the trusts thereof whether in the course of his profession or not and including acts
